

**CUSTOMER LIGHTING AGREEMENT**

1. Department shall supply, install and maintain on property located at \_\_\_\_\_, the hereinafter specified number of automatically controlled overhead lighting fixtures and Department shall deliver approximately 120 volt electric current thereto. Customer shall pay for such service in accordance with the terms and conditions hereinafter set forth.

2. The number of Nightwatchers or Floodlights to be installed hereunder and the monthly rate shall be as follows:

Department will use reasonable diligence to provide at its expense all necessary labor and materials for repairs and maintenance, including bulb replacements, of electric service hereunder after notice is given to Department by Customer that service requires maintenance or repairs. The cost of unusual maintenance resulting from vandalism shall be billed to the customer. If payment for such unusual maintenance is not received, the Lighting Agreement shall be terminated and the Department's facilities will be removed.

4. The facilities installed by the Department in the performance of this Agreement shall remain the property of Department and Customer hereby grants to Department the right to enter and to use Customer's premises as it is necessary for the installation, maintenance and removal of such facilities.

5. Where nightwatchers or floodlights for service hereunder are installed on Department facilities located along public streets or alleys, this contract is subject to any requirements of local municipal authorities.

6. The term of this Agreement shall be from \_\_\_\_\_, 20\_\_ or from the date service is first made available for a period of not less than one year and shall be automatically extended for successive periods of one year each until terminated by written notice given by one party to the other. **If service, at the above location, is terminated for any reason prior to the One year anniversary, the customer will be assessed the remaining monthly payments equaling twelve months.**

7. The customer should contact any adjacent property owners which may be affected by the above light to determine if shielding of the fixture may be required.

8. This document, including any other provisions which may be shown on the reverse side hereof, constitutes the entire and only agreement between the parties hereto with reference to the subject matter hereof and supersedes all previous understandings whether written or oral.
